STUD FEE

A fee of _____ USD is to be paid in full before the breeding takes place. A \$500 USD non-refundable deposit is required to lock in the current rate and secure breeding with said stud. All deposits are nonrefundable. However, if the STUD is unavailable due to unforeseen circumstances, the deposit can be transferred to another available stud owned by the STUD owner.

SEMEN COLLECTION/ SHIPPING COSTS

_____ Shipping and semen collection fee within the continental United States is \$500 flat rate which includes semen, semen extender, priority Next Day shipping, and all packaging material necessary to ship chilled, fresh semen.

_____ The bitch owner must report any issues with the semen quality prior to use or all guarantees will be voided.

_____ International shipping fees will vary depending on collection method (frozen or chilled), type of shipment, location, and if any testing is required.

_____ Frozen semen can be shipped at the bitch's owner expense and a quote will be supplied by the vet.

BREEDING TERMS

_____ The Stud Owner guarantees a healthy and viable semen sample at the time of the semen collection prior to shipping. The STUD owner is not responsible for delayed shipment, negligence or force majeure after the package is delivered to the carrier.

_____ The Stud Owner guarantees three live puppies in one breeding.

_____ If less than 3 live puppies are produced, a second breeding (no guarantee on litter size for the repeated breeding) will be provided to the same bitch (at no additional charge for the STUD fee) within one year of this whelping, provided the Bitch Owner notifies the Stud Owner within 14 days of the whelping date. The bitch's owner will be responsible for any additional semen collection and shipping expenses.

_____ If the bitch fails to conceive a litter the second time, a third and FINAL breeding will be provided (at no charge for the STUD fee) on the bitch's next heat cycle. The bitch's owner will be responsible for any additional semen collection and shipping expenses. A substitute bitch may be used but will be solely at the Stud Owners discretions and subject to a \$500 transfer fee.

_____ Progesterone testing is required and MUST be done by a licensed Veterinarian prior to all breeding's including repeat breeding's. Proof of said testing may be requested by Stud Owner at any time.

_____ Stud Owner has the right to request all documented proof of any breeding that results in only two live puppies, failure to conceive, or any other instances where less than three live puppies were produced.

_____ Stud Owner is not required to issue any refunds and or credits unless the Stud is proven to not be able to provide viable sperm adequate for breeding, to be determined by a licensed reproduction veterinarian.

_____ Any issues with semen quality, upon receipt and proper testing must be testing by a licensed veterinarian. Testing results must be reported to the STUD owner prior to insemination. Any deviation to this will void all guarantee on semen and bitch owner agrees to use the semen at their own risks.

LITTER REGISTRATION

_____ A copy of the Litter Registration Application(s) will be submitted to the Stud Owner upon completion by the bitch owner, including all necessary litter and bitch information and signature of the registered bitch owner. The stud owner will fill out the STUD section and sign and return the application to the registered bitch owner within 48 hours. All litter registration applications are to be emailed to mcsbullyfarm@gmail.com.

BITCH OWNER AGREEMENTS

_____ The Bitch Owner guarantees that this bitch has not been exposed to any stud dog prior to being bred to this stud, and that she will be protected from such exposure after the breeding has taken place. If any question of parentage should arise, the Stud Owner reserves the right to request DNA testing of the puppies at the Bitch Owner's expense.

_____ The Bitch Owner agrees to contact the Stud Owner promptly after the puppies are born and report the sex and color of the puppies.

_____ The Bitch Owner understands and agrees that any guarantees given verbally or in writing to the puppy buyers from this breeding, are the sole responsibility of the Bitch Owner.

_____ Stud Owner has permission to share information with any owners of the sire's offspring or close relatives, as well as post the information on their website/Social media outlets. Proper credits will be given.

OTHER TERMS AND AGREEMENTS

_____ If the STUD credit is not used within the first 2 years of the signed contract date, the STUD owner(s) reserves the right to apply a fee for the entire cost of freezing and storage of the STUD's semen, to the Bitch's owner(s). This is to ensure the availability of the STUDs semen in the event of the STUD's expiration or any unforeseen breeding impairment(s).

_____ The STUD credit may not be resold or transferred without the approval of the STUD owner(s) and is subject to a \$500 transfer fee.

_____ The terms of this agreement are to be kept completely confidential and is not to be shared with outside parties.
